

LETTER OF AUTHORITY

And the Undersigned does hereby grant unto it's agent, full power and authority to receive or obtain the USERID, Login ID and password to establish or amend the Carrier's Organization Record, Tariff Rules, Regulations, Provisions and Rates located in the FMC's Service Contract Filing System (SCFS), if applicable; to research the historical Tariff Rules, Regulations, Provisions, Rates, and/or Assessorial Charges of competing Ocean Common Carriers; to change the password assigned for access to the system as necessary or upon the Undersigned's request; to file and/or sign, where permissible under Federal Maritime Commission regulations and/or Rules of Practice and Procedure, the following documents with the Commission: Letters of Transmittal, Special Permission Applications, Special Docket Applications, Financial Certifications, Formal and Informal Replies before the Commission, Protests, Complaints, Requests for Clarifications, or any other Tariff or Federal Maritime Commission related Document as specifically authorized and directed by the Undersigned. The Authority granted herein is limited solely to the filing, publishing, hosting and retrieval of Tariff matter and/or signing of Federal Maritime Commission related documents and does NOT grant any Authority to publish any Tariff or Document without specific instructions directing such publishing and does NOT permit such agent on it's own to fix or change any rate or charge or in any manner to establish or change any rules or regulations or provisions of such Tariff.

AND THE UNDERSIGNED DOES HEREBY GIVE AND GRANT UNTO IT'S AGENT FULL POWER AND AUTHORITY TO DO AND PERFORM ALL AND EVERY ACT HEREIN ABOVE AUTHORIZED AND SPECIFIED AS FULLY, AND TO ALL INTENTS AND PURPOSES, AS IF THE SAME WERE DONE AND PERFORMED BY ITSELF, HEREBY ADOPTING AND AFFIRMING AS IT'S OWN ALL THAT IT'S AGENT MAY LAWFULLY DO BY VIRTUE HEREOF, AND ASSUMING FULL RESPONSIBILITY FOR THE ACTS AND NEGLECTS OF IT'S SAID AGENT HEREUNDER. THE AUTHORITY HEREIN GRANTED SHALL CONTINUE UNTIL CANCELED OR REVOKED BY EITHER PARTY IN WRITING. EFFECTIVE THIS DATE, THIS LETTER OF AUTHORITY CANCELS AND NULLIFIES ANY SIMILAR AUTHORITY PREVIOUSLY GRANTED TO ANY OTHER PERSON, PARTY, OR CORPORATION.
